The pledge of allegiance was recited.

Motion by Trustee Pesch, second by Trustee Dineen, to accept the January 12, 2022 Regular Board Meeting, minutes of the January 12, 2022 Village Caucus, minutes of the January 19, 2022 Special Board Meeting, and the Financial Report as of January 31, 2022. Motion carried 5-aye

PUBLIC COMMENTS: One citizen made public comments to the Board.

Discussion was held on Community Center and Village Garage regarding potential purchase of the properties. Pat Michels informed the Board of Michels Corp. interest in the properties.

Discussion on the Springfield Solar project.

Motion by Trustee Pesch, second by President Kemmel, to withdraw objection to Dodge Co. Zinke lot split pending with Dodge County, authorize Village president and Village attorney to negotiate a Joint Development Agreement with developers of Springfield Solar, LLC. Motion carried 5-aye

Discussion on Ordinance 2022-01: To limit chloride services in sewer. DNR on efficient water softeners.

Agreement with Fond du Lac ambulance service. Village Attorney Schuessler is working with the City of FDL to add termination language to the proposed agreement.

Motion by Trustee Pesch, second by Trustee Dineen, to accept the Brownsville Lions Club donation of \$2,500 with thanks to be used for playground equipment at Pine Hill Park. Motion carried 5-aye
