The pledge of allegiance was recited.

Motion by Trustee Pesch, second by Trustee Dineen, to approve minutes of October 11th, 2023, Regular Board Meeting, and the Financial Report as of October 31st, 2023; motion carried. 5-aye

Supt. Lechner's Report included:

- Leaf pickup behind due to weather and Lomira DPW availability.
- PSC approved 2024 Public Fire Protection charges.
- Fall flushing will be completed along with closing of the park, restrooms, etc., done before winter.
- Slow leak in the area, still unable to locate.
- The sewer conference went well. Looking to purchase new equipment to help with leak detection.
- Chloride reduction plan for the year end and upcoming with Culligan.
