ORDINANCE NO. 2024-01

VILLAGE OF BROWNSVILLE, DODGE COUNTY, WISCONSIN

An Ordinance to Adopt Fire and Fire Prevention Codes

WHEREAS, the village board of the Village of Brownsville desires adopt a fire prevention ordinance consistent with state and national standards, to support code enforcement and facilitate new construction in the Village of Brownsville which complies with fire codes.

NOW, THEREFORE, the Village Board of the Village of Brownsville do ordain as follows:

Section 1. Codes Adopted.

Section 9.02 of the Brownsville Municipal Code is repealed and re-created to read as follows:

9.02 Adoption of Fire Prevention Codes.

A. Wisconsin Administrative Code. Except as otherwise specifically provided in this chapter, the following chapters of the Wisconsin Administrative Code are hereby adopted by reference and made a part of this chapter as if fully set forth herein. Any act required to be performed or prohibited by any statute or regulation incorporated herein by reference is required or prohibited by this chapter. Any future amendments, revisions or modifications of the statutes or regulations incorporated herein are considered to be part of this chapter in order to secure uniform statewide regulation. Wisconsin Administrative Code chapters adopted:

SPS 307	Explosives and Fireworks
SPS 310	Flammable, Combustible and Hazardous Liquids
SPS 314	Fire Prevention
SPS 316	Electrical
SPS 328	Smoke Detectors and Carbon Monoxide Detectors
SPS 340	Gas Systems
SPS 361 to 366	Commercial Building Code

- **B.** National Fire Protection Association. The following codes of the National Fire Protection Association (NFPA) are adopted by reference:
 - (1) NFPA 231D, Standard for Storage of Rubber Tires.
 - (2) NFPA 501A, Standard for Fire Safety Criteria for Manufactured Home Installations, Sites, and Communities.
 - (3) NFPA 704, Standard System for the Identification of the Hazards of Materials for Emergency Response.

- $\underline{\mathbf{C}}$. Wisconsin Statutes. The following sections of the Wisconsin Statutes are adopted by reference:
 - (1) Section 941.10, Negligent handling of burning materials.
 - (2) Section 941.12, Interfering with firefighting.
 - (3) Section 941.13, False alarms.
- **D.** Violation and Penalty. For violation of the provisions of this section, see Chapter 25 of this code.
- **Section 2**. The appropriate village officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.
- **Section 3**. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.
- **Section 4**. This ordinance shall take effect and be in force upon its passage and publication as provided by law.
